## **EXHIBITION REGULATIONS**

1The exhibit must be owned by the exhibitor

- 2 Each entry shall comprise 16 pages, with each page not to exceed 29x23cm
- 3 The entry fee is \$10.00 per entry
- 4 All exhibits should be on white or lightly coloured pages. The pages are to be contained in clear, close fitting exhibition protectors. Photocopies or scans of a complete cover /stamp must be at least 25% different in size from the original.
- 5 Each page shall show the exhibitors name on the reverse and each page should be numbered, on the reverse in the bottom right corner, or on the front of each page, sequentially in the order that they are to be mounted.
  6 The completed Entry Forms with a copy of the **title page** must reach the Exhibition Secretary, NO LATER THAN 30 September 2023.
- 7 Exhibitors will be advised by 13<sup>th</sup> October that their entry has been accepted or not.
- 8 Once an exhibitor has been notified of acceptance and paid the entry fee, the exhibitor is obligated to provide the agreed entry.
- 9 All entries, except those to be delivered by hand, must be in the hands of the Exhibition Committee by 9<sup>th</sup> November. If exhibits are sent by courier they should be sent signature required to Canpex Inc. P O Box 18-914, New Brighton, Christchurch 8641. Hand-delivered exhibits must be received at the Exhibition venue (Te Hapua Centre, 341 Halswell Road, Halswell, Christchurch) by 10.00am am on Thursday 16th November 2023.
- 10 All reasonable care will be taken by Canpex Inc, its Exhibition Committee and its representatives to protect the property of exhibitors, but the insurance of an exhibitor's property during transit, at the exhibition or otherwise, is solely the responsibility of the exhibitor. Canpex Inc, its Exhibition Committee and its representatives shall not be responsible for any loss or damage to an exhibit in whole or in part, howsoever caused, and the Exhibitor's signature on the entry form indicates acceptance by the Exhibitor of this Regulation.

- 11 The Exhibition Committee or Jury reserve the right to transfer any entry to another Class if in their opinion it is incorrectly placed, or where it may receive a higher award.
- 12 Judging will be carried out on the material as presented in the frames. The New Zealand Philatelic Federation Standard Exhibition Judging Sheets will be used to evaluate each competitive exhibit. A copy of the Judging Sheet will be supplied to the entrants of competitive exhibits/
- 13 All exhibits will be returned as soon as is practicable after the Exhibition. Entries may be uplifted by exhibitors or their duly authorised agent notified in writing, at approx. 6 pm on Saturday, 18th November 2023 at the Exhibition venue after all frames have been dismounted.
- 14 The Exhibition Committee may, from time to time, provide or amend these rules to cover any other matter, which may be required, and its decision is final on all matters.
- 15 Non-competitive displays can be from any of the above classes There will be no written critiques as displays will not be judged.
- 16 The modern traditional experimental class is for a traditional exhibit of modern material (i.e. within the last 50 years.)
- 17 Medals will not be awarded, but there will be a grand award and some special prizes. All entries will receive a certificate.
- 18 Completed entry forms and a copy of the title page should be sent to Canpex Inc, P O Box 18-914, New Brighton, Christchurch 8641 or emailed to canpexinc@outlook.com
- 19 The Exhibitor's signature on the entry form indicates acceptance of all rules laid down by the Exhibition Committee in this prospectus.
- 20 Exhibits not conforming to the exhibition regulations may not be judged or displayed.
